ANNOUNCEMENT AND CALL FOR PARTICIPATION in SAMBHAV 2020, An International Event
Of Seminar on Disability & Yoga, Dance & Music Therapy Exposition, Art & Craft Exhibition & Workshop and
Performances by Artists with Disability
For Sharing of Best Practices in Advancing Rights of
DIVYANGJAN, Persons with Disability (Locomotor and Intellectual Impairment) through Inclusive Arts

On 06.07 & 08 November 2020 at IIC, New Delhi, India

1. **Sambhav**, as the name implies in Sanskrit, is something which „is possible“. Over the LAST TWELVE years, SAMBHAV has grown to become a major international platform of inclusive arts in the Indian national capital. It showcases inclusiveness of Indian society and also brings together such efforts by *Divyang* (physically and mentally challenged) artists in other countries. The Association for Learning Performing Arts & Normative Action (A.L.P.A.N.A.), a not-for-profit registered organization, has established this as a yearly event, providing a unique forum to challenged artists and stakeholders across the world. Our Prime Minister has recently articulated inclusiveness of global society with particular emphasis on **DIVYANGJAN** (persons with blessed ability). A.L.P.A.N.A. has been working with *Divyangjan* since 2003.
2. A.L.P.A.N.A. invites artists (singer / dancer/ musician / mime / play) with disability to participate in the three days' event, SAMBHAV 2020 to be held at New Delhi from 06 – 08 November 2020.
3. The participants have to reach New Delhi by early morning of 05 November 2020 for pre-event activities. They should plan to leave on 09 November 2020. The organizers would not extend any assistance to participants reaching Delhi before 5 Nov 2020 (morning) or leaving after 9 Nov 2020 (afternoon) in respect of their early arrival or late departure. The interested participants must pre-register with full details, themes video sample etc. as per enclosed format, by 30 June 2020. The applicant must send the scanned copies of filled registration form by email, addressed to **Guru Alpana Nayak**, President, Association for Learning Performing Arts & Normative Action (A.L.P.A.N.A.) on email address: alpanasociety@gmail.com. We will provide local hospitality (shared accommodation in International Youth Hostel, Nyaya Marg, Chanakyapuri, New Delhi or similar type of accommodation), food and local transport only to those participants whose registration is accepted and confirmed by us. We will notify the acceptance of registration by 31 August 2020.
4. Over the last fifteen years A.L.P.A.N.A. has organized or participated in sixty five performing arts events by **Divyangjan (mentally and physically challenged) persons** at major venues in India and abroad. A.L.P.A.N.A. presented Sambhav-2006, Sambhav-2007, Sambhav-2008, Sambhav-2009, Sambhav-2010, Sambhav-2011, Sambhav-2012, Sambhav-2013, Sambhav-2014, Sambhav-2015, Sambhav-2016, Sambhav-2017, Sambhav-2018 and Sambhav-2019 events comprising of International Seminars, International Art & Craft Exhibition, International Art & Craft Workshop, International Yoga Workshop, Heritage Site Visits, Interactions in Indian Schools for the participants and International Dance / Music Performances by the specially gifted persons (artists with disability).

5. The fourteenth edition of SAMBHAV held on 15, 16 and 17 November 2019 at India International Centre, Lodi Estate, New Delhi attracted 17 groups from Australia, Bangladesh, Bhutan, Iran, Mongolia, Myanmar, Nepal, Russia, Sri Lanka, Tajikistan, USA, Uzbekistan and Vietnam besides 13 groups from Indian States of Delhi, Gujarat, Madhya Pradesh, Nagaland, Odisha, Rajasthan, and West Bengal. In his special message to A.L.P.A.N.A., **Hon'ble Prime Minister of India** had appreciated SAMBHAV 2018 for *"providing the platform to our Divyang sisters and brothers to showcase their talents."*

6. We aim to have participation in **SAMBHAV 2020**, of performing artists (**singer / dancer/ musician / mime / play**) with disability from across the world, with whom India has friendly relations. During Sambhav 2019 several **Memoranda of Understanding** to collaborate on areas of mutual interest were signed by A.L.P.A.N.A. with the premier civil society organizations from the participating countries and in **SAMBHAV 2020** we aim at entering into **MoU with counterpart organizations going to take part in SAMBHAV 2020.**

7. Objectives of SAMBHAV

- a. To promote inclusive growth and be a catalyst in fulfilling commitments of the global society towards persons with disability.
- b. To showcase inclusiveness of Indian Society and Indian Heritage.
- c. To empower challenged persons, particularly artists, through development of skills and enhancement of creativity in various fields of arts.
- d. To work towards sharing of ideas, knowledge, achievements and experiences through sustainable interactions among different stake holders.

8. What are the various activities being planned in SAMBHAV 2020?

SAMBHAV 2020 will be held on 06-08 November, 2020 at New Delhi. The event will include:

- a) **International Seminar** on **"Divyangjan: Artists with Disability for an inclusive society."**
- b) **International Seminars on yoga, the best gift of Indian culture to the world and Yoga Workshop**
- c) **Forum for International Cooperation** to advance the Rights of Women, the Rights of Children and the Rights of Persons with Disability.
- d) **International Art & Craft Exhibition** of paintings, sculptures and artifacts made by artists with disability.
- e) **International Art & Craft Workshop**
- f) **International Workshops on Dance Therapy and Music Therapy**
- g) **International Event of Performances** by artists with disability from different countries
- h) **Exposure visits to Heritage Sites**
- i) **Interaction visits to Indian Schools**

9. Who can participate in SAMBHAV 2020?

SAMBHAV 2020 will have following categories of participation:

Category A. Children and Young Performing Artists with Disabilities

Children and youth (performing artists: dancers / musicians/ singer / mime / play) with different kinds of disabilities i.e. blind, deaf, physical, mental etc. They will be from different countries of the world. They will put up performances (20 to 25 minutes duration by each group) during the SAMBHAV.

Category B. Experts and practitioners working with challenged persons

Domain experts, gurus, dance therapists, music therapists, mental health professionals, medical doctors, art instructors, therapy administrators, policy makers, diplomats, media persons, legal professionals, rights advocates, students etc. will attend the international seminar. They will be from different countries of the world.

Category C. Challenged Artists

Challenged painters, sculptors, weavers, designers etc. They will exhibit their arts and artifacts at the international exhibition. They will be from different countries of the world.

Category D. Managers of organizations working with Persons with Disabilities

Executives, managers, mentors and leaders of organizations, including service providers and innovators working for Persons with Disability from different countries will be part of the Forum on International Cooperation.

Category E. Caretakers and Caregivers for PswD

10. GENERAL INFORMATION

Conditions for international participants:

- i. Individuals or groups falling under any one or more than one Categories (A to E) mentioned above, representing a COUNTRY, and willing to travel to New Delhi can participate in SAMBHAV 2020.
- ii. **Individuals and groups must pre-register by 30 June 2020** by sending scanned copies of filled registration form by email on address: alpanasociety@gmail.com.
Our acceptance of registration will be notified by 31 August 2020.
- iii. Performances (dance / music) have to be only by persons with disabilities including mentally and/or physically challenged persons.
- iv. A group of **maximum 3 PERSONS** including Disabled Performers (dancers / musicians / singers / mimicry artists / actors) and team leader/ resource person / caretakers (if any) from a country can participate in SAMBHAV.
- v. We have limited funds and based on its availability,
 - **WE MAY REIMBURSE, subject to availability of funds, CHEAPEST ECONOMY CLASS AIR TRAVEL FARE FROM THE CAPITAL CITY OF THE PARTICIPATING FOREIGN GROUP FOR MAXIMUM 3 PERSONS INCLUDING CHALLENGED PERFORMING ARTISTS (SINGERS / DANCERS / MUSICIANS / MIMICRY ARTISTS / ACTORS) TO NEW DELHI AND BACK IN CASE OF OUTSTANDING AND DESERVING GROUPS BASED ON THEIR APPLICATION AND PROPOSED PERFORMANCE BY CHALLENGED ARTISTS DETAILS. WE WILL NOT REIMBURSE EXTRA FARE, BEYOND CHEAPEST ECONOMY CLASS FARE, IF ANY, DUE TO LATE PURCHASE OF AIR TICKETS BY THE INVITED PARTICIPANTS.**
 - **WE WILL NOT REIMBURSE AIR TRAVEL FARE TO GROUPS WHICH DO NOT HAVE CHALLENGED ARTISTS (DANCER / MUSICIAN / SINGER/ MIMICRY ARTISTS / PLAY) IN THEIR GROUP WHO WILL PUT UP PERFORMANCES AT SAMBHAV.**

- NO VISA FEE WILL BE REIMBURSED BY US.
 - WE WILL NOT PAY ANY PERFORMANCE FEE.
 - A.L.P.A.N.A. WILL PROVIDE LOCAL HOSPITALITY LIKE SHARED ACCOMMODATION AT INTERNATIONAL YOUTH HOSTEL, NYAYA MARG, CHANAKYAPURI, NEW DELHI OR SIMILAR TYPE OF ACCOMMODATION, FOOD AND LOCAL TRANSPORTATION TO THE PARTICIPATING GROUPS (FOR THE PERIOD 05 NOVEMBER 2020 (ARRIVAL) TO 09 NOVEMBER 2020 (DEPARTURE) ONLY.
 - ALL OTHER EXPENSES SUCH AS TRAVEL WITHIN COUNTRY OF ORIGIN, TRAVEL INSURANCE (IF APPLICABLE), VISA ETC. ARE TO BE BORNE BY THE PARTICIPANTS OR THEIR SPONSORS.
- vi. The participants must reach New Delhi by early morning of 05 November 2020, since the preparatory activities will take place during the day on 05 November 2020. Participants have to participate in preparatory activities. The participants have to be present at the venue of SAMBHAV and take part in all activities of SAMBHAV. **They are not supposed to make any other engagements other than SAMBHAV participation during the period of hospitality, i.e.05– 09 November 2020.**
- vii. The schedule of performances will be in the evenings of 06 - 08 November 2020. The duration of performance (dance/ singing / mimicry/ theatre / singing / band playing) by a group could be maximum of 20 to 25 minutes. Traditional art forms and dance/music performances by disabled persons should be the theme. Write up on the performances, names and photographs of artists and recorded music / video **should be sent along with registration format submission by email or link given to video / youtube on or before 30 June 2020. This will be considered by Selection Committee Process** for the groups/individuals. We will confirm the acceptance of participation requests sent with complete particulars, by 31 August 2020 through email so that the participants may make their travel arrangements for **taking benefit of possible low fares in travel as can be seen on online ticketing websites such as www.skyscanner.co.in.**
- viii. Challenged artists (painters, crafts persons etc) may arrange to send their exhibition material for display in the international exhibition event.
- ix. The leader/ resource person of the group representing a country will **present a paper on the theme** in the International Seminars. The name of the paper presenter and abstract of the paper should reach us by **01 October 2020.**
- x. Visa, travel documentation etc will be the responsibility of the invited organization/individual. A.L.P.A.N.A. writes to the Indian Diplomatic Missions outside India about SAMBHAV 2020. We will not reimburse visa fees, if any.
